NOTICE OF ANNUAL MEETING AUGUST 13, 2023 SPRINGER PARK 1:00 P.M.

The deadline to vote by dropping off or mailing your ballot will be August 11th, with the ballot counting being done on August 12th.

Ballots can also be dropped at the Annual Meeting prior to the start of the meeting at 1:00 p.m.

Timberlake Community Club's annual meeting will be held on Sunday, August 13, 2023, at 1:00 p.m. at **Springer Park**.

Directions to Springer Park:

From the main entrance – coming into Timberlake: (Signs will be posted)

- Stay on the main road (Timberlake Drive) to the boat launch. Take right into parking lot, go through field (to the right) Park at edge of field across from the gazebo.
- Stay on the main road (Timberlake Drive), turn right onto E Pickering Dr, take the next left onto E Lakeshore Dr W and the parking lot will be the first driveway on the left.

There are four issues to be voted on this year:

- 2023-2024 General Budget
- 2023-2024 Water Budget
- Audit
- Board of Director Positions

You may vote by mail. If you choose to vote by mail, follow the instructions carefully to make sure your vote is counted. Your Ballot must be received at the Timberlake MPC Ballot Box by 5:00 p.m. on Friday August 11, 2023.

If you do not vote by mail, you may drop your ballot in the ballot box at the **MPC or on election day** your ballot must be placed in the ballot box at Springer Park no later than 1:00 p.m. August 13, 2023.

In order for your vote to count you must be a member in good standing (no covenant issues and your account current).

OFFICIAL BALLOT INSTRUCTIONS FOR 2023

In order for your ballot to be counted and valid you must:

RESERVE STUDY INFORMATION

The enclosed Reserve Study information is being provided per State law and is <u>NOT</u> a statement that describes any actions the TLCC Board is taking in the proposed budget.

WATER RESERVE BILLING INCREASE

The Reserve Funding billing is being increased from \$270.00 to \$300.00 per year. This will result in a bi-monthly billing increase of \$5.00. The Water Base Rate is increasing from \$252.00 to \$265.00 per year. This will result in a bi-monthly billing increase of \$2.17. This is being done in accordance with our Reserve Study recommendations to maintain the sustainability of our water system.

BUDGET VOTING INFORMATION WASHINGTON STATE LAW RCW 64.38.025

Board of directors -- Standard of care -- Restrictions -- Budget -- Removal from board.

(3) Within thirty days after adoption by the board of directors of any proposed regular or special budget of the association, the board shall set a date for a meeting of the owners to consider ratification of the budget not less than fourteen nor more than sixty days after mailing of the summary. <u>Unless at that meeting the owners of a majority of the votes in the association are allocated or any larger percentage specified in the governing documents reject the budget, in person or by proxy, the budget is ratified, whether or not a quorum is present. In the event the proposed budget is rejected, or the required notice is not given, the periodic budget last ratified by the owners shall be continued until such time as the owners ratify a subsequent budget proposed by the board of directors.</u>

AUDIT VOTING INFORMATION

WASHINGTON STATE LAW RCW 64.38.045

Financial and other records -- Property of association -- Copies -- Examination -- Annual financial statement -- Accounts.

(3) At least annually, the association shall prepare, or cause to be prepared, a financial statement of the association. The financial statements of associations with annual assessments of fifty thousand dollars or more shall be audited at least annually by an independent certified public accountant, but the audit may be waived if sixty-seven percent of the votes cast by owners, in person or by proxy, at a meeting of the association at which a quorum is present, vote each year to waive the audit.
