MESSAGE FROM THE OFFICE

There seems to be a misunderstanding of our Election system here in Timberlake. I would like to clear that up and help educate everyone on our process.


There is only ONE ballot per owner, regardless of how many lots are owned. 1) When your ballot arrives mark your choices and place the ballot in the envelope marked BALLOT. 2) Place your BALLOT envelope inside of the ELECTION COMMITTEE envelope and print your name, address and Lot and Division number in the upper left corner. A lot of people think that by doing this their vote is not anonymous, however that is not true. After the owner's name has been crossed off of the voting list (to make sure there isn't anyone casting more than one ballot) the outside envelope is removed, and all of the BALLOT envelopes are put into a stack. 3) Then all the BALLOT envelopes are opened and counted. There is no way to know which BALLOT envelope went with what ELECTION envelope. Some votes did not get counted this year because there was not a name, address or Lot and Division marked on the Outside ELECTION envelope. I hope I have explained the process clearly but if you have any questions, please call me and I can go into more detail.
